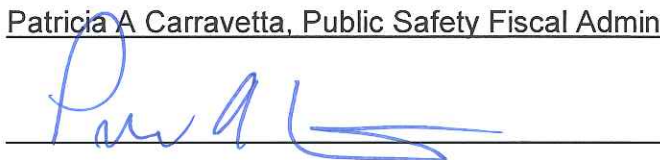

From the Sheriff, request for retro authorization to accept a State of Wisconsin Department of Transportation grant for the Zoo Interchange Rebuilding/Reconstruction Project from January 1, 2016 through August 30, 2018 to mitigate traffic impact and ensure emergency response capabilities are not adversely impacted during construction. Grant funds total \$395,572.93 for 2016, \$407,610.32 for 2017 and \$364,902.55 for 2018.
