Subject: **Request for City of Milwaukee Storm Sewer Easement within the Kinnickinnic Parkway (ACTION)**

### Policy

Parks requests authorization to execute a permanent storm sewer easement with the City of Milwaukee to allow for the construction, operation and maintenance of storm sewer infrastructure within the Kinnickinnic Parkway.

### Background

The City of Milwaukee is currently undertaking a project to reconstruct 60<sup>th</sup> Street in the vicinity of the Kinnickinnic Parkway. Work is planned to include roadway construction between existing sidewalks, and the storm sewer discharge within the parkway will be replaced. The 60" City storm sewer pipe that runs east-west under 60<sup>th</sup> Street will be extended, and rip rap will be placed between the outfall and the river to minimize erosion. The new pipe and tributary area will not increase storm water flow rates into the river.

The City is offering \$1,900 for this permanent easement. Parks, working in coordination with the Economic Development Division, has determined that this is fair compensation for the 0.3 acres impacted. Parks retains the right to require a right-of-entry permit for work on parkland, during which time review of materials, including rip rap, will be evaluated.

As an easement, the storm pipe and the surrounding area will be the responsibility of the City of Milwaukee to maintain. Because KK Parkway is zoned parkland, granting the permanent easement authorization from the Milwaukee County Board of Supervisors and the County Executive.

It is further recommended that that the County Executive and County Clerk be authorized to execute any required documents.
