PURPOSE OF CONTRACT

Under this contract, OEM will provide licensed paramedic level emergency medical services staff to provide non-emergent and emergency medical services to patrons, employees and vendors of the Fiserv Forum during events to include, but not limited to, NBA, NCAA games, and any other entertainment events as determined by Deer District LLC. Services provided by OEM under this agreement will be reimbursed by Deer District LLC at cost plus a 20% administration fee. It is estimated that this agreement will generate approximately \$1.1M in revenue over the 5 year term and that the revenue generated by the agreement will be offset by the costs incurred in providing the service. Actual revenue will vary depending on the number and length of events as well as staffing levels.
