Approval of this request will allow the Director of DHHS to execute purchase of service contracts to continue the provision of contracted Community Service & Restitution Coordination, Level II In-Home Monitoring Services with Optional GPS, Targeted Monitoring Services, Prevention and After Care, Shelter Care, Juvenile Educational Treatment Initiative (JETI), Peer Specialists, Community Accountability Panels for first-time juvenile offenders, Mentoring, the Youth Employment Program, and services related to the Residential Treatment Center for the period January 1, 2019 through December 31, 2019.

- B. Total 2019 expenditures included in this request are \$11,679,045.
- C. There is no tax levy impact associated with approval of this request in 2019 as funds sufficient to cover associated expenditures are included as part of the DYFS 2019 Budget.
- D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
