19 20 21	WHEREAS, the 2019 Milwaukee County (the County) CDBG allocation totals approximately \$1,606,587; and
21 22 23	WHEREAS, 20 percent of the total funds can be used for administration; and
24 25 26	WHEREAS, 15 percent of the total funds can be set aside for public service projects; and
27 28 29	WHEREAS, the allocation continues to be split between large competitive projects and municipal projects; and
30 31 32	WHEREAS, although the municipal projects were not scored and ranked for the purpose of this report, they are included to show the complete allocation; and
33 34 35 36	WHEREAS, projects must serve low-to-moderate income individuals within the County CDBG jurisdiction otherwise the County cannot fund these projects per the United States Department of Housing and Urban Development (HUD) regulations; and
37 38 39	WHEREAS, the HOME program was born out of the National Affordable Housing Act of 1990 and was a spin-off of the CDBG Program; and
40 41 42	WHEREAS, the County is designated as an urban county, and is part of a HOME Consortium with the cities of West Allis and Wauwatosa; and
43 44 45 46	WHEREAS, the Milwaukee County Board of Supervisors' (County Board) approval of the recommendations for the 2019 HOME funding, anticipated to be \$1,856,445, is required to complete the 2019 Annual Action Plan, which is submitted to HUD; and

- WHEREAS, the Wauwatosa and West Allis Consortium member shares are set
 aside based on their "hold harmless" amounts; and
- WHEREAS, all recommended CDBG and HOME projects fit the priorities and
 objectives of the five-year County Consolidated Plan; and

- 54 WHEREAS, all County CDBG and HOME funds must be spent outside of the 55 City of Milwaukee; and
- WHEREAS, pending County Board approval, the 2019 Annual Plan will be
 published for a required 30-day comment period, and any public comments will then be
 incorporated into the final 2019 Annual Plan and submitted to HUD for approval; and
- 61 WHEREAS, in no case will program expenditures exceed available revenue; and 62 projects will be adjusted on a percentage basis if the final award from HUD differs from 63 the County's funding amounts; and
