From the Milwaukee County Comptroller, Office of the Comptroller, requesting authorization to execute a Professional Services Contract with Quarles & Brady LLP, to provide bond counsel services, for the period effective January 1, 2019, through December 31, 2021, with three one-year extension options, by recommending adoption of the following:

## **A RESOLUTION**

WHEREAS, on July 25, 2018, the Procurement Division, Department of Administrative Services, issued a Request for Proposals (RFP) on behalf of the Office of the Comptroller (Comptroller); and

WHEREAS, the RFP anticipated entering into a three-year Professional Services Contract with three additional one-year options; and

WHEREAS, the RFP was advertised in the Daily Reporter, and noticed via Milwaukee County's (the County) E-Notify system, and among those 72 law firms registered with Bonfire, the County's public procurement portal; and

WHEREAS, three responses were received in response to the RFP; and

WHEREAS, an evaluation panel reviewed and scored the proposals; and

WHEREAS, the evaluation panel reached a consensus that the highest scored proposal from Quarles & Brady LLP (Quarles & Brady), should be selected as the winning bidder; and

WHEREAS, Crump Law Firm (Crump), a certified Targeted Business Enterprise (TBE), will serve as co-bond counsel; and

WHEREAS, it is the desire of the Comptroller to enter into a Professional Services Contract with Quarles & Brady to provide bond counsel services for a three-year term beginning on January 1, 2019; and

WHEREAS, the Professional Services Contract will also include three additional one-year options; and

WHEREAS, the fees for bond counsel will be paid on an hourly basis; and

WHEREAS, the hourly fee for the primary attorney from Quarles & Brady is \$425 per hour; and

 46 WHEREAS, the hourly fee for the primary attorney from Crump is \$320 per hour; 47 and 48 49 WHEREAS, the total expenses related to bond issuances done in 2019-2021 will 50 depend upon the number and complexity of the bond issues; and 51 52 WHEREAS, it is estimated that total annual bond counsel expenses, including 53 the TBE fees, will range from \$200,000 to \$450,000 during the period of the contract; 54 and 55 56 WHEREAS, the Committee on Finance and Audit, at its meeting of December 6, 57 2018, recommended adoption of File No. 18-882 (vote 7-0); now, therefore, 58 59 BE IT RESOLVED, the Milwaukee County Board of Supervisors approves the 60 Professional Services Contract with Quarles & Brady LLP, to provide bond counsel 61 services for the period effective January 1, 2019, through December 31, 2021, with 62 three one-year extension options; and 63 64 BE IT FURTHER RESOLVED, the Milwaukee County Comptroller, County 65 Executive, Department of Administrative Services, and Corporation Counsel are 66 authorized to execute the Professional Services Contract referenced in this resolution. 67 68 69 70 71 srb S:\Committees\2018\Dec\F&A\Resolutions\18-882 Quarles & Brady Bond Counsel - Comptroller.docx
