

13	employed by the County of Milwaukee, hereinafter referred to as "Council".

17	In consideration of the mutual covenants herein contained, the parties hereto do hereby mutually
18	agree as follows:

20	PART 1

22	1.01 RECOGNITION
23	The County agrees to recognize, and herewith does recognize, the Council as the exclusive
24	collective Bargaining agent of behalf of the employees of Milwaukee County in accordance with
25	the certification of the Wisconsin Employment Relations Commission, as amended, in respect to
26	wages, pursuant to Subchapter IV, Chapter 111.70, Wisconsin Statues.

1	1.02 EMPLOYEE DEFINED
2	Wherever the term "employee" is used in this Agreement, it shall mean and include only those
3	employees of Milwaukee County within the certified bargaining unit represented by the Council.

5	1.03 DURATION OF AGREEMENT
6	This Agreement is to take effect on January 1, 2018. Unless otherwise modified or extended by
7	mutual agreement of the parties, this Agreement shall expire on December 31, 2018.

11	<u>2.01 WAGES</u>
12	Effective Pay Period 14, 2018 (June 17, 2018) the wages of bargaining unit employees shall be
13	increased by one percent (1.0%).
