Passive Review

POLICY

Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General Ordinance Chapter 56) for Capital projects requires County Board review to award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000. The Director of the Department of Administrative Services (DAS) is requesting passive review of a fee increase to extend the professional service contract for the operation and maintenance of the landfill gas control system at Doyne Park.

BACKGROUND

Milwaukee County owns a closed landfill located under what is now Doyne Park. The landfill was closed in 1976 but continues to generate landfill gas, which is potentially explosive under certain conditions. Concerns over the migration of landfill gas from the landfill into adjacent residential areas prompted the County to undertake investigations and ultimately the installation of a landfill gas migration control system in the late 1990's.

The County operates the gas migration control system in compliance with Wisconsin Department of Natural Resources (DNR) requirements. Since 1999, Milwaukee County DAS has contracted for the service of maintenance and testing of the landfill gas control systems on an annual contract basis. In January of 2017, the County received proposals to perform operation and maintenance of the landfill gas control system. Milwaukee County awarded a contract for operation and maintenance for the year ending December 31, 2017 to AECOM for a not-to-exceed sum of \$44,592 for the Doyne Park landfill.

The contract agreement provides that the County may extend the agreements for two additional one year periods if the consultant requests an extension and the request is approved by the County. In January of 2018, the contract was extended for the year ending December 31, 2018 for an increase of \$29,446.67 and a total contract not-to-exceed sum of \$74,038.67. AECOM-has performed its work-well and has been very-responsive to problems at the Doyne Park landfill site. At the request of DAS, AECOM

has submitted a proposal for repair of the landfill gas system and extension of the operation and maintenance agreement from January 1, 2019 through December 31, 2019 for an increase of \$64,710.26 and a total contract not-to-exceed sum of \$138,748.93. The proposal's combined costs are typical to past costs to repair and maintain the landfill system.
