A RESOLUTION/ORDINANCE

WHEREAS, Section 69.02(2) of the Milwaukee County Code of General Ordinances establishes parking regulations for South 76th Street (County Trunk Highway U), pursuant to the authority established by Section 349.13, Wisconsin State Statutes: and

WHEREAS, the Department of Transportation was requested to review a concern for vehicles entering South 76th Street from various driveways; and

WHEREAS, it was determined that there is a potential safety concern created by the existing parking on the West side of C.T.H. U; and

WHEREAS, the Committee on Transportation, Public Works, and Transit, at its meeting of January 23, 2019, recommended adoption of File No. 19-93 (vote 3-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 69.02(2) of the Milwaukee County Code of General Ordinances by adopting the following:

AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

SECTION 1. Section 69.02(2) of the Milwaukee County Code of General Ordinances is hereby amended as follows:

69.02. – Parking prohibited in designated areas.

No person shall stop or leave any vehicle standing in any of the following places, except temporarily, for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a licensed operator:

- (1) College Avenue (C.T.H. 'ZZ')
 - (a) Between the limits of South 20th Street and South 27th Street.
 - (b) On the south side, from a point four hundred fifty (450) feet east of South 35th Street to the limits of South 27th Street.
