3 From the Chief Judge, First Judicial District, Combined Court Related Operations,
4 requesting authorization to extend the Safety and Justice Challenge Project Manager
5 contract in an amount not-to-exceed \$172,620 for oversight, management, and fidelity
6 to the grant program for the period effective March 1, 2019, through December 31,
7 2020, by recommending adoption of the following:

11 WHEREAS, on April 13, 2016, Milwaukee County (the County) received from the
12 John D. and Catherine T. MacArthur Foundation a funding award notice for the Safety
13 and Justice Challenge Phase II Implementation in the amount of \$2,000,000; and
14

15 WHEREAS, the award period is from May 1, 2016, to April 30, 2018, with the
16 possibility to extend an additional year; and

18 WHEREAS, on May 26, 2016, the Milwaukee County Board of Supervisors
19 (County Board) authorized the Chief Judge to accept the Safety and Justice Challenge
20 Phase II Implementation grant from the John D. and Catherine T. MacArthur Foundation
21 (16-1601-150542-CJ) for the Safety and Justice Challenge Phase II (File No. 16-271);

24 WHEREAS, on December 15, 2016, the County Board authorized the Chief
25 Judge to issue an 18-month contract for the Safety and Justice Challenge Project
26 Manager position not-to-exceed \$127,500 (File No. 16-679); and
27

28 WHEREAS, the County will increase the total 18-month contract amount for the
29 Safety and Justice Challenge Project Manager position by \$7,019, from a total of
30 \$127,500 to \$134,519; and

32 WHEREAS, on December 20, 2018, the County received a funding award notice
33 for the Safety and Justice Challenge Phase III Implementation and Community
34 Engagement grant in the amount of \$2,300,000; and

36 WHEREAS, the Phase III application included the position of Safety and Justice
37 Project Manager in the amount of \$172,620 for the duration of the grant; and

39 WHEREAS, the Safety and Justice Challenge Project Manager position will
40 continue to be administratively located at the Wisconsin Policy Forum as part of the
41 Milwaukee Community Justice Council; and

43 WHEREAS, the Committee on Finance and Audit, at its meeting of February 1,
44 2019, recommended adoption of File No. 19-74 (vote 6-0); now, therefore,
45

46 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
47 authorizes the Chief Judge, First Judicial District, Combined Court Related Operations,
48 to increase the Safety and Justice Challenge Project Manager position contract to an

49 amount to not exceed \$172,620 for the 22-month contract period from March 1, 2019, to
50 December 31, 2020.
