11 12 13 14 15 16	WHEREAS, on March 17, 2016, the Milwaukee County Board of Supervisors (County Board) adopted File No. 16-200 authorizing the creation of the Milwaukee County Task Force on the Mitchell Park Conservatory Domes (the Domes Task Force), which was tasked with the development of a comprehensive, long-term plan for the Mitchell Park Horticultural Conservatory (the Domes); and
17	WHEREAS, the County Board adopted File No. 16-347 on June 23, 2016, which
18 19 20 21 22	included an amendment to Fund Transfer E1, creating a Mitchell Park Domes Long- Tem Planning sub-account within Capital Improvement Project WP49003 Mitchell Park Domes and included a transfer of \$472,000 from the Appropriation for Contingencies; and
23 24 25 26 27	WHEREAS, the Domes Task Force hired three consultants, ConsultEcon, Inc., HGA, and Quorum, Architects, Inc., to conduct a two-phase Future Path and Feasibility Study with the funds from the Mitchell Park Domes Long-Term Planning sub-account; and
28 29 30 31	WHEREAS, ConsultEcon, Inc., and HGA prepared the management and economic insight Phase I Study, including site and market analyses, as well as eight potential options for the future of the Domes; and
32 33 34 35	WHEREAS, Quorum Architects, Inc., held focus groups and public hearings, as well as administered an online survey, to gain feedback on the eight options considered by the Task Force; and
36 37 38	WHEREAS, using feedback from local interest groups, the consultants, and the public, the Task Force moved forward with a recommendation of two options:
39 40 41 42 43	 Targeted investments in facilities and operations, including restoration of the existing structures Targeted investments and investment in the creation of an EcoDome Destination Attraction

WHEREAS, the Domes Task Force continues its work by partnering with the Milwaukee Public Museum Task Force to share information from the Future Path and Feasibility Study and continue pursuing a comprehensive, long-term plan for the Domes; and

WHEREAS, the 2018 Adopted Capital Budget included Capital Improvement Project WP55301 Mitchell Park Conservatory Planning, which allocated \$320,000 for Phase III of the Future Path and Feasibility Study; and

WHEREAS, the Department of Administrative Services estimated that the cost for a Phase III Request for Proposals (RFP) would be \$120,000; and

WHEREAS, it is the recommendation of the Domes Task Force that the funds from Capital Improvement Project WP55301 Mitchell Park Conservatory Planning be used to further analyze the two suggested options and continue development of a comprehensive, long-term plan for the Domes by administering an RFP; now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) supports the work of the Milwaukee County Task Force on the Mitchell Park Conservatory Domes (the Domes Task Force) and the Milwaukee Public Museum (MPM) Task Force, which is studying the possibility of co-location of the Domes and the MPM, adopted in the 2019 Budget; and

BE IT FURTHER RESOLVED, the Department of Administrative Services (DAS) is directed and authorized to process an administrative transfer of \$120,000 from Capital Improvement Project WP55301 Mitchell Park Conservatory Planning to Capital Improvement Project WP49003 Mitchell Park Domes Long-Term Planning; and

BE IT FURTHER RESOLVED, the County Board authorizes the Domes Task Force to use the appropriated funds for the Phase III Request for Proposals; and

BE IT FURTHER RESOLVED, the Department of Parks, Recreation, and Culture and the Facilities Management Division, DAS, is authorized to proceed with materials analysis and study of the concrete and window glazing at the Mitchell Park Domes, results of which are necessary to inform the final recommendation(s) of the Domes Task Force; and

BE IT FURTHER RESOLVED, the Domes Task Force is requested to provide its final recommendations to the County Board by the September 2019, cycle for consideration with Milwaukee County's annual budget.
