RE: Informational report on former Unison contracts

Background

Per File 18-897, which the County Board of Supervisors approved on December 13, 2018, the Department on Aging is required to submit monthly reports to the Milwaukee County Board of Supervisors as an update on contracts formerly held by Unison.

MCDA has contracts in place with Serving Older Adults of Southeastern WI (SOA) to manage the five county-owned senior centers and the dining sites located inside of those senior centers. All senior centers and dining sites at those centers opened as normal on January 2nd and will continue to remain open on their normal schedule. All senior center programming questions can be directed to Vevette Hill, SOA's Senior Vice President, at [vevettehn@servingolderadults.org](mailto:vevettehn@servingolderadults.org) or 414-704-3343. MCDA's Jill Knight can also answer questions about senior center programming activities.

Regarding other senior dining services, MCDA has a contract in place with Goodwill to manage the home-delivered meal program, and those services started on January 2nd and continue to operate as normal. With regard to the 13 remaining congregate dining sites which are not being managed by SOA, services started on January 2nd and continue to operate on their normal schedule. MCDA is temporarily contracting with PS Companies to pay dining site supervisors until a permanent managing vendor can be found. MCDA has met with prospective vendors to discuss taking on the management of these 13 sites and hopes to have a contract in place by the end of January. In short, all senior dining services (congregate meals and home-delivered meals) continue as normal. Specific senior dining questions can be directed to MCDA's Beth Monrial Zatarski, Senior Dining Program Director, and senior dining information can also be found on the MCDA website at <https://county.milwaukee.gov/EN/Department-on-Aging/Senior-Centers-Dining>.

Regarding Family Caregiver Support Network (FCSN) services, MCDA has received verbal confirmation from the Alzheimer's Association that they will manage these services in 2019. MCDA is working with the Alzheimer's Association on a 2019 contract and hopes to have a contract in place by the end of January. In the interim and until a contract is signed with the Alzheimer's Association, caregivers who call MCDA's Aging Resource Center seeking respite services have their contact information taken by MCDA staff. MCDA staff also document the caregiver's need for respite. Follow-up will be provided by the Alzheimer's Association upon finalization of the contract. Regarding the Neighborhood Outreach Program (NOP) and neighborhood outreach services, while MCDA is no longer subsidizing these services, Unison management has indicated to us that they continue to manage these services for older adults without MCDA funding.
