

- A. This resolution, if adopted, will declare Milwaukee County's policy position that the State of Wisconsin should increase funding for county child support agencies.
 - B. This resolution will not require the expenditure of funds. The County Clerk will use existing staff time to communicate the policy to the officials and entity specified in this file. This fiscal note does not attempt to quantify the fiscal impacts on Milwaukee County if the State of Wisconsin decides to increase funding to county child support agencies. If the State increases funding to the County, then at some point the Department of Child Support Services may request an appropriation transfer recognizing the additional revenue and increasing expenditures or the Department may include the increased revenue in its budget requests for future fiscal years.
 - C. This resolution will not have a budgetary impact in current nor subsequent years, since personnel costs are already budgeted within the County Clerk's office.
 - D. No assumptions nor interpretations were utilized to provide information for this form.
