- A. The Office of the Comptroller is requesting approval of the attached parameters resolution for the issuance of a not-to-exceed ("NTE") amount of \$74,230,000 of general obligation bonds ("Bonds") and/or general obligation promissory notes ("Notes") to finance various capital projects that have already been approved by the County Board and County Executive. The resolution also delegates the bid opening and approval of the winning bidder for the sales of the Obligations to the Comptroller. The Comptroller's approval is limited to sale results that fall within the parameters outlined in the resolutions.
- B. The estimated combined debt service costs for the not to exceed amount of \$74,230,000 is \$92,970,000 including \$18,740,000 in interest.
- C. There is no current year budgetary impact since the debt payments will not begin until 2020 and the bond/note revenues are already budgeted for the individual projects. The 2020 Budget will need to include principal and interest expenses for the 2019 debt that is being issued. The incremental total general obligation bond debt service payments would increase by an estimated \$900,000 if the total NTE amount were issued. The Parameters Resolution indicates an effort will be made to structure the Obligations to make the annual debt service payments on all of the outstanding debt and projected future debt as level as possible.

D. The costs of issuance will not exceed the federally allowable 2% of the par value of the bonds. The estimated total debt service is based on five separate schedules. 1) an estimated NTE of \$32,735,000 of 10-year "Notes" for bus purchases and Bus Rapid Transit 2) an estimated NTE of \$18,540,000 of 15-year Bonds to finance various long term projects 3) an estimated NTE of \$12,390,000 of 5-year Notes to finance Enterprise Platform Modernization ("ERP") 4) an estimated NTE of \$6,510,000 of 5-year taxable Notes to finance various project with private activity issues 5) an estimated NTE of \$4,050,000 of 4-year Notes to finance short-term equipment projects. The estimated rates are based on the current Municipal Market Data ("MMD") AAA Curve adjusted for the County's current bond ratings (Aa2/AA/A+) plus 50 basis points. A 5 percent coupon is assumed for each series.
