A. The Milwaukee County Treasurer is requesting to fund 0.5 FTE and create 1.0 FTE Assistant Accounting Treasury positions to staff functions for countywide centralized accounts receivable necessitated by the new ERP financial system.


B. In 2019, direct costs to the Office of the Treasurer will include salaries and social security for the final three quarters of the year as well as one-time technology and furniture costs to accommodate the additional staff. In 2020, direct costs include the full year salaries of the employees.

C. In 2019, the Milwaukee County Treasurer will absorb the increases within their existing allocation. In 2020, the new positions will be submitted as part of the Treasurer's budget request.

D. Assumptions for this analysis include a 2nd quarter start date for the new employees and the annualized 2% increase for 2020 executed in pay period 13 of 2019.
