- A. Request to enter into a Vendor Permit Agreement for Paddleboat Rental Concession Services at the Lakefront with Funtime LLC D/B/A Wheel Fun Rentals. The current vendor permit expires in 2020 and Wheel Fun wishes to enter into a longer agreement in order to make a large investment into new, improved paddleboats for its operations.
 - B. Wheel Fun Rentals agrees to pay the DPRC \$23,250 in 2019, \$23,500 in 2020, \$23,750 in 2021, \$24,000 in 2021, \$24,250 in 2022, \$24,500 in 2023 if renewed, and \$24,750 in 2024 if renewed, plus 20% of gross receipts greater than the total amount invoiced.
 - C. Entering into this vendor permit agreement will ensure a steady revenue stream in years 2021-2024 as noted above.
