- A. Approval of this By the Committee resolution supports the adoption of a preferred governance model to operate and oversee inmate medical services. The resolution also outlines a definition of "self-operation" for inmate medical services for approval by the Milwaukee County Board of Supervisors.
 - B. This resolution does not allocate or obligate any funds. It endorses a preferred governance model. This resolution also defines "self-operation" of inmate medical services to guide staff and consultants in the development of a plan to insource these functions.
 - C. This resolution has no budgetary impact since it does not require the expenditure of funds. It should be noted that significant staff time is required to continue to develop a plan to insource inmate medical services.
