Description of Program/Service

The *Outreach in Public Housing* program provides services to older adults in certain public housing buildings (Arlington Court, Becher Court, Cherry Court, College Court, Convent Hill, Highland Gardens, Holton Terrace, Lapham Park, Lincoln Court, Locust Court, Merrill Court, Mitchell Court and Riverview Court). The purpose of the grant is to provide outreach and referrals for MCDA's long term care programs to older adults living in the housing buildings. SET is able to provide .99 of a position with this grant, with 10.69 FTEs total working in the public housing program. The majority of program staff are HUD grant funded.

In addition to providing referrals to MCDA's long term care programs, SET Ministry provides a variety of outreach services including wellness training, health promotion, disease prevention, and social and recreational activities to the total population of the selected public housing projects.

Client Satisfaction Survey

Client satisfaction surveys are not required for this contract.

Progress on Outcome Measures

Set Ministry's contract calls for them to serve 3960 service hours, or about 330 hours per month for all program activities, including the activities that are supported by HUD grant funding. This number of service hours is well beyond what a .99 FTE can provide.

Service hours are provided through individual and group activities such as monthly health promotions (e.g. wellness clinics) and information sessions. There are also social groups and clubs, such as, cooking clubs and a garden club. At all events and activities, Aging Resource Center outreach information and materials are made

available to all attendees. Additionally, SET staff, who are all social workers or licensed therapists, meet one- on -one with any resident seeking help or information.

At the sixth- month mark SET should have completed 1,980 service hours in order to be in compliance with the grant outcome measures However, in the past outcomes were measured by the number of people served, not by service hours. With this change, it may be that the suggested outcome was set to high. If looking at the number of events, the partnerships with outside organizations, and the relationships SET has with the building residents, the program appears to be successful.

Program Administration

The administration of the *Outreach in Public Housing* contract in regards to client record keeping, number of events, community partnerships, and program growth is satisfactory. Staff offices and programs are located inside of the public housing buildings and residents know and trust the staff.

As successful as the daily program administration is, monthly billing and reporting to the MCDA is unsatisfactory. In the past, although the contract stated that reporting should be done monthly, MCDA accepted billing and reporting annually for this grant. This year, it was communicated that reporting was expected monthly. SET was unable to provide the reporting monthly. Reports were submitted for the months of January through June on August 2, when MCDA staff completed their site visit. It is understood that the merger with Interfaith has caused some delay as everyone learns their new roles, however, going forward MCDA would like SET/UNISON to submit accurate program and financial reports on a monthly basis.

2018 Recommendations

The Department on Aging proposes the following recommendations:

Recommendation #1: Monthly program and financial reporting will be submitted to MCDA accurately and on time, according to the terms found in the 2018 contract, for the months of August, September, October, November, and December 2018.

Recommendation #2: SET ministries will provide MCDA with a written explanation as to how the monthly target outcomes are set each month for indicator #4 Dissemination of LTC information and #6 LTC referrals. This explanation will be provided to MCDA by September 15th, 2018.

Senior & Adult Disabled Services

Case Management

Since 1993, HACM has partnered with <u>SET Inc.</u> to provide case management and other services to seniors and disabled adults who live in HACM's buildings. Every year, SET assists more than 1,300 public housing residents by assessing their needs, determining their eligibility for programs and services, and linking them to critical resources. SET also case manages many residents eligible for the State of Wisconsin's Family Care program, which helps frail seniors and persons with disabilities to age in their homes.

Senior Meal Sites

HACM developments host five senior meal sites managed by the Milwaukee County Department on Aging. Whether they live in HACM buildings or not, persons 60+ can participate in the low or no-cost meal programs at the United Community Center's Senior Center at Olga Village, Convent Hill, Lapham Park, Arlington Court and College Court.
