- A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute a purchase of service contract under passive review with St. Charles Youth and Family Services for the Alternative Sanctions Program.
- B. Total 2019 expenditures included in this request are \$294,000 for May 1 to December 31, 2019. The period of January 1 to April 30, 2019 was covered by a contract with Wisconsin Community Services (WCS) for \$225,394 for both the Saturday Alternative Sanctions and the Evening Reporting Center Programs during the appeal process. The 2019 Budget anticipated that these two programs would be combined for a total cost of \$441,000 and create a savings in the budget. For this reason, the continuation of separate contracts at a higher rate for the first four months of 2019 is anticipated to result in an increased cost of \$78,394. The total annual projected cost is \$519,394 compared to the \$441,000 budget, reflecting an increase of \$78,394. This cost can be absorbed within the 8000 contractual services account series for DYFS.
- C. There is no tax levy impact associated with approval of this request in 2019 as funds sufficient to cover associated expenditures are included in the DYFS 2019 Budget.
- D. This fiscal note assumes expenditures will not exceed the amount authorized for this purchase of service contract.
