Providing an informational report regarding the extension to Vendor Agreement with the Friends of Hoyt

Park and Pool for The Landing Beer Garden (INFO)

#### Issue

Milwaukee County Parks is providing an update on the Vendor Agreement with the Friends of Hoyt Park and Pool for the beer garden that supports Hoyt Pool.

# **Background**

Milwaukee County Parks and the Friends of Hoyt Park and Pool ("Friends") have partnered for the capital improvement and operation of the Hoyt Pool since 2007 and in 2013 a beer garden known as The Landing was added to that facility. The pool and all improvements are governed by a Lease agreement that is in effect until 2046 and the beer garden was added by a vendor agreement that is subordinate to the Lease. In 2018 the agreement was extended for one season and in 2019 the agreement was extended for an additional 10-year term.

Under the terms of the Vendor Permit, the Friends of Hoyt Park and Pool pay to the County 10% of all net revenue on food and beverage sales and an additional 2.5% of net revenue to a maintenance fund for the facility.

The attached report highlights the positive contributions of the Friends including their investments in the facility, focus on swim lessons and youth from all over Southeastern Wisconsin, and environmental conservation efforts that they support in the Menomonee River and Hoyt Park.
