Legislative reports are submitted to one or more of the 8 County Board Standing Committee's for adoption. Approval or rejection of these adoptions takes place during the Committee of the Whole meeting, in which all supervisors are present. Reports can be submitted to any or all the 10 cycles in the year. Please note, County Board meetings are not held during the months of February and August. The deadlines for submitting reports to these cycles is detailed below.

To ensure timely report processing, please practice the following:

- Reports, fiscal notes, resolutions, and any other supporting documentation should be uploaded to the appropriate committee folder in SharePoint. All files uploaded should be of FINAL and COMPLETE status. Once in SharePoint, all associated files should be clearly titled for easy access and reference.
- Reports and Fiscal notes should be uploaded <u>unsigned</u>. "Wet signatures" or physical signatures are requested by the County Clerk's office to maintain document originality. Signatures will be obtained post report approval.
- Per the County Clerk's procedures, resolutions should be uploaded in Word format only (.docx). This is the only document that applies to this specific format.
