This email is being shared with members of the Finance and Audit Committee in response to a question regarding Vehicle Registration Fee revenues, which was raised at the October 8, 2019 meeting.

The Milwaukee County Vehicle Registration Fee (VRF) is \$30. The fee was first included in the 2017 budget for Milwaukee County, and revenue collections began in March of 2017. Revenues from this fee can only be used for transportation related activities like roads, highways, bridges and public transportation. The fee remains at \$30 in the 2020 Recommended Budget and it is projected to result in \$17,163,509 of total revenue. Of this amount, the 2020 Recommended Budget allocates \$16,101,243 or 94% to the Transit department operating budget. \$1,062,266 or 6% is allocated to the Highway Maintenance operating budget. There are no VRF revenues allocated to capital projects in the 2020 Recommended Budget, which is consistent with the 2019 Adopted Budget. In 2017 and 2018 a portion of the funds were allocated to capital projects.

The following chart provides a history of budget and actual VRF revenues for Milwaukee County, as well as a breakout of the 2020 Recommended Budget for VRF. The chart includes details regarding where the revenues are allocated.
