- A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to amend 2019 Disabilities Services Division purchase of service contracts with Birth to 3 agencies.
- B. Approval of this request will increase the overall amount executed in Birth to 3 contracts by \$80,000, from \$4,525,106 to \$4,605,106.
- C. There is no tax levy impact associated with approval of this request as funds sufficient to cover the associated expenditures are budgeted for 2019. Due to staff vacancies throughout the majority of 2019, the program is projected to be underspent by about \$80,000. These contract amendments would enable the program to meet its federal Maintenance of Effort (MOE) requirement.
