- A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to enter into 2020 purchase of service contracts with a variety of community vendors for services to persons with disabilities and others with special needs within the DHHS-Disabilities Services Division (DSD).
- B. Approval of this request will result in an expenditure of \$5,149,504 for 2020. This reflects a reduction of \$270,978 compared to the purchase of service contracts approved in 2019. As indicated in the narrative, the respite contract with Broadscope was eliminated for \$211,095, the staff support component of the Life Navigators contract was eliminated for \$100,000 and an additional \$40,117 was added to annualize the amount for the Broadscope Employment Options contract.
- C. There is no tax levy impact associated with approval of this request in 2020 as funds sufficient to cover associated expenditures are included as part of DSD's 2020 Budget.
- D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
