Mayor Kennedy called the Executive Council of the MMSD meeting to order at 1:04 p.m. A quorum was present.

I. Approval of the October 14, 2019 Minutes

II. Report of the Commissioners

Mayor Ehley reported on the Operations Committee that met the previous week. Mayor Ehley highlighted a sinkhole repair project underway to the Honey Creek culvert under State Fair Park. The committee reviewed and recommended the following items:

Mr. Shafer reported that a portion of the Jones Island Facility will be partially closed for a major repair. Flow will be diverted to South Shore for several weeks.
