## **A RESOLUTION**

WHEREAS, the Department of Human Resources (DHR) was requested to review the classification of Correction Manager positions as the compensation appeared to be out of alignment with market rates and conditions; and

WHEREAS, the Director of Compensation/Human Resources Information Systems, DHR, reviewed the request to reallocate the classification of 10 Correction Manager positions, seven in the House of Correction, and three in the Office of the Sheriff; and

WHEREAS, DHR reviewed the duties of the positions, and compared the classification (compensation) with other similar and related positions relative to market rates and conditions; and

WHEREAS, the Director of Compensation/Human Resources Information Systems, DHR, recommends that the classification of Correction Manager positions (title code 00077120) be reallocated from pay grade 915E to 916E, effective pay period 1, beginning December 15, 2019; and
