From the Milwaukee County Comptroller, Office of the Comptroller, requesting authorization to execute a Professional Services Contract with PFM Financial Advisors LLC, to provide municipal advisory services, for the period effective January 1, 2020, through December 31, 2022, with three one-year extension options, by recommending adoption of the following:

A RESOLUTION

WHEREAS, on September 4, 2019, the Procurement Division, Department of Administrative Services, issued a Request for Proposals (RFP) on behalf of the Office of the Comptroller (Comptroller); and

WHEREAS, the RFP anticipated entering into a three-year professional services agreement with three additional one-year options; and

WHEREAS, the RFP was advertised in the Bond Buyer and Daily Reporter, and

WHEREAS, the RFP was noticed via Milwaukee County's (the County) E-Notify system to all of the financial advisors that are registered with Bonfire, the County's public procurement portal; and

WHEREAS, two responses were received to the RFP; and

WHEREAS, an evaluation panel reviewed and scored the proposals; and

WHEREAS, the evaluation panel reached a consensus that the highest scored and lowest cost proposal from PFM Financial Advisors, LLC, (PFM) should be selected as the winning bidder; and

WHEREAS, Independent Public Advisors, LLC, a certified Targeted Business Enterprise (TBE), will continue to serve as co-municipal advisor; and

WHEREAS, it is the desire of the Comptroller to execute a professional services contract with PFM, to provide municipal advisory services for a three-year term, beginning on January 1, 2020; and

WHEREAS, the professional services agreement will also include three additional one-year options; and

WHEREAS, the fees for bond counsel will be paid on an hourly basis; and

WHEREAS, the hourly fee for the primary advisor from PFM is \$225 per hour;

 and

47 WHEREAS, the total expenses related to bond issuances done in 2020 through 48 2022 will depend upon the number and complexity of the bond issues; and 49 50 WHEREAS, it is estimated that total annual municipal advisory expenses, 51 including the TBE fees, will range from \$125,000 to \$275,000, during the period of the 52 contract; and 53 54 WHEREAS, the Committee on Finance and Audit, at its meeting of 55 December 12, 2019, recommended adoption of File No. 19-872 (vote 6-0); now, 56 therefore, 57 58 BE IT RESOLVED, the Milwaukee County Board of Supervisors approves the 59 professional services contract with PFM Financial Advisors, LLC, to provide municipal advisory services from January 1, 2020, to December 31, 2022, with additional options 60 61 for three, one-year terms; and 62 63 BE IT FURTHER RESOLVED, the Milwaukee County Comptroller, County 64 Executive, Department of Administrative Services, and Corporation Counsel are authorized to execute the professional services contract referenced in this Resolution. 65 66 67 68 69 70 srb 12/12/19 S:\Committees\2019\Dec\F&A 121219\Resolutions\19-872 Comptroller - POS Contract PFM Financial Advisors.docx
