From the Director, Risk Management, Department of Administrative Services, requesting approval to authorize Aon Risk Services to bind the 2019 property and casualty insurance program for Milwaukee County through purchasing of the following insurance policies with an effective date of January 1, 2020 expiring December 31, 2020, Public Entity Liability: Wisconsin County Mutual Insurance Corporation - \$1,039,414, Property: Travelers Insurance - \$1,791,346, Energy Systems: Liberty Mutual - \$68,432 Airport Liability: AIG - \$138,739, Fidelity/Crime: Great American - \$45,353; Fiduciary: AIG (primary) - \$213,311; Chubb (1<sup>st</sup> XS) - \$85,313, Axis (2<sup>nd</sup> XS) - \$42,000, Fine Arts: AXA - \$75,757; Insurance program premium total: \$3,499,665, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the Risk Management Division (Risk Management), Department of Administrative Services (DAS), procures the property and casualty insurance program for Milwaukee County (the County); and

WHEREAS, the Committee on Finance, Personnel, and Audit recommended adoption of the resolution contained in File No. 15-405, which was adopted by the Milwaukee County Board of Supervisors at its June 25, 2015, meeting, authorizing Risk Management to contract with Aon Risk Services (Aon) for property and casualty insurance brokerage; and

WHEREAS, the 2020 Adopted Budget appropriated \$4,865,957 for Risk Management to procure property and casualty insurance to protect the County; and

WHEREAS, Aon marketed the County's insurance program, and negotiated broader coverage on behalf of the County for the 2020 insurance program; and

WHEREAS, Risk Management and Aon recommend that coverage be bound with the insurance policies captioned above for the protection of the County's assets, operations, employees, clients, and the public; and

WHEREAS, the Committee on Judiciary, Safety, and General Services, at its meeting of December 5, 2019, considered File No. 19-914 for information only; and

WHEREAS, the Committee on Finance and Audit, at its meeting of December 12, 2019, recommended adoption of File No. 19-914 (vote 6-0); now, therefore,
