- A. The Office of Emergency Management Emergency Medical Services (EMS) Division provides medical coverage to support contracted venues within the county to provide onsite Paramedic response capabilities, known as the Special Events Paramedics. The venues we serve are as follows: Milwaukee County Zoo, UWM Panther Arena Admirals Hockey, and the Fiserv Forum. The Fiserv Forum is our newest contract and offers more than double the events than we had covered when previously working at the BMO Bradley Center. A full-time supervisor position is needed to ensure proper coverage and coordination of events due to this increase in event activity.
- B. This resolution will have no additional costs or savings. Revenue is generated as the requesting venue is charged the employee's base rate plus FICA plus a 20% administrative fee.
- C. There are no budgetary impacts related to this action in the current year. Subsequent capital and operating costs are non-existent as the equipment, supplies and salaries are billed directly to the venue requesting our services.
- D. There are no assumptions or interpretations made herein.
