Additional Comments

Milwaukee County sustained flooding and major damage to its shoreline, infrastructure and recreational areas caused by the severe weather event occurring Friday, January 10th through Sunday, January 13th 2020.

Lake Michigan has water levels that are at near record levels at about 4 feet over normal heights. This past weekend, an intense low pressure system tracked to the southeast of Milwaukee and left a prolonged period of strong easterly fetch winds from Friday, 1/10 through Saturday, 1/11. Gusty, northeast winds came on Saturday, reaching 50-60 mph, pushing large waves and water in low elevation areas while also eroding bluffs.

- Due to snow cover and possible other unseen damage, this estimate summary may grow as melt and thaw occurs.
- City of Milwaukee and Milwaukee County insurance coverage assessments are pending.
- Milwaukee County has a \$750,000 insurance deductible.
- Municipalities are still investigating damages.
- Estimates for Milwaukee County and Port of Milwaukee provided by staffed professional engineers.
