From the Director of the Office of Emergency Management (OEM), requesting authorization to add forty (40) OEM Hourly Paramedic Trainers to provide adequate staffing levels for medical operations at our Special Events venues, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Special Events Paramedics have seen an increase in demand for hours, personnel, and tempo; and

WHEREAS, historically the hours worked in all venues averaged 300 hours monthly; and

WHEREAS, special events venues are now requesting 900 hours or more per month; and

WHEREAS, the Special Events Paramedics staffing will need to increase significantly over the next six months, to ensure event coverage is adequately provided as contractually obligated; and

WHEREAS, the Special Events Paramedics activity has increased, and may at times require an hourly paramedic to fill in as a Shift Leader; and

WHEREAS, this role shall be compensated at a shift differential of \$2.00 per hour, charged directly to the venue; and

WHEREAS, Emergency Medical Services (EMS), Division Office of Emergency Management (OEM), providers work in other Milwaukee County (the County) departments, such as, but not limited to, Milwaukee Mitchell International Airport, EMS-OEM, and OEM Communications; and

WHEREAS, allowing them to function as a dual-role County EMS provider at our special events would be advantageous, as they currently work for the system, and are familiar with policies and practices; and

WHEREAS, these resources could be utilized in times of need with scheduling shortages; and

WHEREAS, the cost of the positions is fully reimbursed by the contracted venue, resulting in no tax levy impact; and

WHEREAS, the Committee on Finance and Audit, at its meeting of January 30, 2020, recommended adoption of File No. 20-96 (vote 6-0); now, therefore,

48 hereby authorizes and approves the creation of 40 Hourly Paramedic Trainer positions
49 in the Emergency Medical Services Division, Office of Emergency Management –
