The attached resolution would create 2 positions in Retirement Plan Services and eliminate the need for contractual services spending from the Pension Fund.

The direct costs of creating the positions is \$118,779 annually and \$68,526 in 2020. Creation of these positions would eliminate the need for \$143,556 of annual spending in contractual services in the Pension Fund. The County reimburses the pension fund for administrative costs with a one-year lag, so the savings in the pension fund in 2020 will be realized in 2021 in the form of a lower pension contribution in Org 1950 – Employee Fringe Benefits. The increase cost in 2020 is can be absorbed due to the high level of current vacancies in RPS.

This fiscal note assumes that both new positions will be filled with 15 pay periods remaining in 2020 at the first step of the range. This fiscal note also assumes that the Pension Board will approve reducing contractual costs in 2020 and future years.
