3 Report from the Director, Department of Health and Human Services, requesting  
4 authorization to amend the 2020 purchase of service contract with Running Rebels  
5 Community Organization within the Division of Youth and Family Services, by  
6 recommending adoption of the following:

8 **A RESOLUTION**

10 WHEREAS, the Director, Department of Health and Human Services (DHHS), is  
11 requesting authorization to execute a Purchase of Service Contract with Running  
12 Rebels Community Organization (RRCO) for programming and services for the  
13 Milwaukee County Accountability Program (MCAP) for 2020; and  
14

15 WHEREAS, in December 2019, the Division of Youth and Family Services  
16 (DYFS), DHHS, received approval under File No. 19-884 to execute a Purchase of  
17 Service Contract with RRCO for a period of January 1, 2020, through April 30, 2020, for  
18 services related to MCAP; and  
19

20 WHEREAS, DYFS-DHHS, plans to develop the same programming whether a  
21 portion of Vel Phillips remains as MCAP, or becomes a Secured Residential Care  
22 Center for Children and Youth under Wisconsin Act 185; and  
23

24 WHEREAS, MCAP offers intensive supervision, structure, support, and skill-  
25 building opportunities for youth who are court ordered into the program as well as  
26 provides an out-of-home placement of up to 180 days in a secure setting, transition, and  
27 aftercare planning and intervention; and

29 WHEREAS, starting in 2020, a Dialectical Behavior Therapy group will be  
30 launched within the MCAP with other components set to include: restorative justice  
31 practices, individual and family therapy, Global Positioning System monitoring while out  
32 in the community on home passes, art participation, education support, and other  
33 individualized services as needed; and

35 WHEREAS, the contract recommendation is consistent with the 2020 Adopted  
36 Budget; and  
37

38 WHEREAS, the Committee on Finance and Audit, at its meeting of March 18,  
39 2020, recommended adoption of File No. 20-229 (vote 6-0); now, therefore,  
40

41 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby  
42 authorizes the Director, Department of Health and Human Services, or her designee, to  
43 enter into a 2020 Purchase of Service Contract, effective May 1, 2020, to December 31,  
44 2020, with the provider and in the amount listed below:
