WHEREAS, the Department of Human Resources (DHR) was requested to review the classifications of the aquatic staff (Lifeguard Seasonal, Head Lifeguard Seasonal, Assistant Head Lifeguard Seasonal, Lifeguard Supervisor Seasonal, and Head Lifeguard) as the positions have become increasingly difficult-to-fill, resulting in the closure of some Department of Parks, Recreation, and Culture's (DPRC) aquatic facilities due to lack of staff; and

WHEREAS, the Director of Compensation/Human Resources Information Systems, DHR, reviewed current compensation levels, job duties, and requirements and comparative market data for similar jobs in the area; and

WHEREAS, the review indicates that current compensation levels for these positions lag the market; and

WHEREAS, the uneven pay increases to different pay grades of aquatic classifications over the last decade, have created an imbalanced pay structure for these pay grades; and

WHEREAS, the Director of Compensation/Human Resources Information Systems, DHR, after discussion with and input from DPRC Aquatic services leadership, recommends and requests approval for the reallocation of the following classifications; and
