    - i. DAS-FMD

DAS-FMD has a good supply of PPE and sanitizers. DAS-FMD is now looking at options for phased re-occupation (including requirements for cleaning and communication), in coordination with Courts and others. Some DAS-FMD staff is being furloughed.

ii. DHHS

BHD is looking at how to phase closures of portions of the Mental Health Complex.

iii. MCDOT

The Administration building is open to the staff for the Sheriff's substation, but office staff are teleworking. Fleet staff are on-site, highway supervisors are working remotely.

iv. Zoo

Zoo staff is starting discussions on how to re-open, considering preselling admission tickets on-line. Zoo staff are looking for direction on making playgrounds open and available. Zoo staff also trying to determine how to count the total number of visitors, either as individuals or families. Some Zoo staff is worksharing.

v. Parks

Some golf courses are re-opening, in accordance with Governor Evers' orders. Warmer weather will require seasonals to get certain areas operational. Parks is requiring COVID-19 preparedness plans as part of vendor contracts. Parks is furloughing and worksharing some staff.
