Subject: 2020 FEMA Disaster Funding for Lakefront Storm Damage (INFO)

Issue

Informational update on efforts by Milwaukee County Parks and the Office of Emergency Management (OEM) to acquire Federal Disaster Funding for Storm Damage in January of 2020.

Background

On January 10-12, 2020 Milwaukee County experienced significant storm damage along the Lake Michigan coast as a result of both historically high-water levels and damaging wave action. Both Parks and OEM have been working with FEMA to ascertain what resources through disaster funding may be available to clean up, repair, and mitigate the damages experienced. At the time of this report the January storm event had been declared a Presidential Disaster. Future work will include submission of a detailed damage summary, definition of project scopes, and multiple project agreements. Projects funded in this way have funding that would be split 75% Federal, 12.5% State, and 12.5% Local share. Total funding needs are being developed based on the following initial list of identified needs:
