13	WHEREAS, the County received an allocation of \$992,237; and
14 15 16 17	WHEREAS, CDBG COVID-19 funding allows for more flexibility in the use of funds to encourage immediate use; and
18 19	WHEREAS, 20 percent of the total funds can be used for administration; and
20 21 22	WHEREAS, funding can be used to recoup costs for COVID-19 related costs already incurred; and
23 24 25 26	WHEREAS, the County has partnered with the City of Milwaukee (the City) Health Department to open a COVID-19 isolation facility for those with housing instability; and
20 27 28 29	WHEREAS, the County has also partnered with the City to place at-risk individuals in hotels to ensure proper isolating environments; and
30 31 32	WHEREAS, the County has historically used CDBG funds to assist with the development of small businesses; and
33 34	WHEREAS, the Metropolitan Milwaukee Fair Housing Council (MMFHC) was
35	formed by 40 local citizens in 1977 to combat racial and economic segregation and discrimination in the housing market and to promote fair housing; and
36 37	WHEREAS, MMFHC has distinctive programs respectively focused on fair
38 39	housing enforcement, outreach and education, fair lending, and inclusive communities; and

41 42 43 44	WHEREAS, the United States Department of Housing and Urban Development, has allowed the reallocation of existing Community Housing Development Organization HOME funding to be used for tenant-based rental assistance; and
44 45 46 47	WHEREAS, the Committee on Economic and Community Development, at its meeting of May 18, 2020, recommended adoption File No. 20-353 as amended (vote 5-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board)
hereby authorizes the Director, Department of Health and Human Services (DHHS), or
her designee, to allocate the total anticipated 2020 Community Development Block
