- B. Award of professional services agreements to raSmith for design services for capital project WP538 – Root River Parkway Reconstruction – Parkway – 92nd St. & Parking Lot. This results in a not to exceed total fee of \$107,923.00 for WP538.
- C. The adopted 2019 capital budget included a total of \$153,142 for capital project WP538. There are sufficient funds in the capital budget to award the requested professional services agreement to raSmith. The 2019 capital budget includes funding for design only of project.
