SUBJECT: Informational Report – Dispersal of Community-Based County Services

The 2020 budget included Amendment 1A018, which directed the Department of Administrative Services to study the operational and capital feasibility of dispersing community-based County services to two locations outside of the Downtown Milwaukee area, presumably one site generally in the northern portion of the County and one in the southern portion. This informational report provides an update on that study, with initial findings. Further study is required to determine the operational and capital benefits, requirements and constraints.

Background

2020 Budget Amendment 1A018, sponsored by Supervisor Alexander, requested a report of the feasibility of locating community-based County services, to facilitate easier access to services by constituents.

In a related effort, the Department of Administrative Services (DAS) is currently working on an administrative space strategic facility plan. The intent of the Administrative Space Strategic Facility Plan is to provide strategic direction to utilize available County resources and accommodate evolving administrative and customer service function requirements more effectively. DAS-Facilities Management Division will use the findings and recommendations from the administrative space strategic facility plan to support development of facility master space plans and tactical plans to house County functions, and to help the County achieve a sustainable facility footprint. The administrative space strategic facility plan focuses on the following County facilities:

Additionally, DAS-FMD has been working closely with DHHS in the planning for the development of its 'No Wrong Door' approach to provision of community services, which includes a separate plan for a new community-based consolidated administrative office for the full range of DHHS services. This project may align with the intent of the Budget Amendment 1A018 as locations outside of the downtown Milwaukee area are under consideration. DHHS will file a separate report to the Board on this project.

Summary of Initial Findings

As part of the data collection for the administrative space strategic facility plan, DAS-FMD Facilities Planning staff polled County departments on their interest in developing some sort of presence in a satellite facility. The following departments expressed such an interest:

Future Activities

Pending clarity of the County budget situation, DAS Facilities Planning and Development staff will retain a consultant to develop facility and real estate strategies for the administrative space strategic facility plan, which will include development of scenarios, business cases and implementation plans to achieve short-, medium-, and long-term goals. The analysis of satellite county facilities as requested in 2020 budget amendment 1A018 will be integrated into the consultant's scope of services.
