AMENDMENT TO INFRASTRUCTURE EASEMENT

WHEREAS, the MILWAUKEE COUNTY DEPARTMENT OF PARKS, RECREATION AND CULTURE (“PARKS”) and the MILWAUKEE METROPOLITAN SEWERAGE DISTRICT (“MMSD”) entered into a Permanent Infrastructure Easement which was recorded in the Milwaukee County Register of Deeds office on May 21, 2019 as Document #10872314. It has been determined that permanent access is needed from the public roadway on the PARKS’ parcel to the area of the Permanent Infrastructure Easement, as described in the legal description which is attached to this Amendment and incorporated as Exhibit “A”, and is shown on the plan sheet attached and incorporated as Exhibit “B”.

WHEREAS, PARKS is willing to grant and MMSD is willing to accept a permanent access easement as Amendment to the existing Permanent Infrastructure Easement for the additional sum of \$300.00 dollars to be paid by MMSD to PARKS upon full execution of this Amendment.

NOW, THEREFORE, PARKS and MMSD agree to amend the Permanent Infrastructure Easement as set forth herein. All terms of the Permanent Infrastructure Easement remain in full force and effect.
