3 From the Interim Superintendent, House of Correction, requesting authorization to
4 execute a multi-year service agreement with the Wisconsin Department of Corrections
5 (DOC) and to receive revenue in the approximate amount of \$230,000 a year by
6 allowing DOC inmates to utilize the Milwaukee County Day Reporting Center for a daily
7 fee starting on October 1, 2020 with five, one-year renewal options beginning on
8 January 1, 2021, by recommending adoption of the following:

10 **AN AMENDED RESOLUTION**

11
12 WHEREAS, Milwaukee County (the County) and the State of Wisconsin
13 Department of Corrections (DOC) wish to extend services being provided at the Day
14 Reporting Center (DRC) to DOC inmates; and

15
16 WHEREAS, treatment and intervention strategies for the program will include at
17 a minimum: chemical dependence and substance abuse education; the effects of
18 dependency/abuse on participants' lives; social skills training; self-control training;
19 development of a recovery plan; and relapse prevention skills training using cognitive
20 intervention strategies; and

22 WHEREAS, the Agreement will extend important services to more individuals
23 without increasing the costs of the DRC contract with Wisconsin Community Services,
24 Inc.; and

25
26 WHEREAS, the DOC will pay the County a daily fee of \$46 for a minimum of 20
27 inmates per month to participate in programming at the DRC; and

28
29 WHEREAS, estimated revenue of \$230,000 was included in the House of
30 Correction's 2021 budget request; and

31
32 **WHEREAS, an additional 24 individuals may be able to benefit from**
33 **participation in this program; and**

34
35 **WHEREAS, both the County and the DOC are interested in extension of this**
36 **program to the additional 24 individuals at a rate of \$46 per day, receiving**
37 **approximately \$230,000 in additional revenue; and**

39 **WHEREAS, at its meeting on September 17, 2020, the Committee on**
40 **Finance recommended for adoption File No. 20-630 to extend the contract**
41 **between the County and Wisconsin Community Services, Inc., for management of**
42 **the DRC; and**

43
44 **WHEREAS, increased participation in the program may require an**
45 **additional three DOC staff members, at a cost of up to \$150,000 per year; and**

47 WHEREAS, the Committee on Finance, at its meeting of September 17, 2020,
48 recommended adoption of File No. 20-631 as amended (vote 5-2); now, therefore,

50 BE IT RESOLVED, the Interim Superintendent, House of Correction, is hereby
51 authorized to execute a multi-year agreement with the State of Wisconsin Department
52 of Corrections (DOC) for inmates to utilize the Milwaukee County (the County) Day
53 Reporting Center (DRC) for a daily fee starting October 1, 2020, with five, one-year
54 renewal options beginning on January 1, 2021.; and

56 **BE IT FURTHER RESOLVED, the Professional Services Contract between**
57 **the County and Wisconsin Community Services, Inc., in the amount of \$794,244**
58 **(File No. 20-630) for the DRC may, if approved by the Milwaukee County Board of**
59 **Supervisors, be increased up to \$150,000 more per year for additional staffing**
60 **costs to support this programming agreement with the DOC.**
