- 1. COVID-19 Updates, overview of the OEM Dashboard: Dashboard Link
- 2. DNC Updates: waiting on DNCC for details, no major updates for now,
- 3. Hospital Diversion: Data no diversions on COVID, policy in place for ICU capacity but no need to pull trigger yet, will continue to monitor situation.
- 4. Barriers to testing: Sense in the community that COVID is gone, media is currently focusing heavily on protests, focus on southern part of the county with testing is being identified.
- 5. EMS system activity: Alternate Response Vehicle plan was put into action to sure available units for the EMS system, plan was stopped after approximately 6 weeks as the call volume did not justify keeping the extra units in service.
- 6. Subcommittee on Equity New committee being stood up to assess actions, policies and decisions through the lens of racial and social equity with a focus on patient centered decision making.

- 1. EMS System Kudos to the Fire Chiefs on collaboration and rapid response for the COVID ARV program.
