- The Wisconsin Disability Vote Coalition encourages voters to vote early because of concerns about COVID-19.
Some voters with disabilities prefer also voting absentee because of difficulty getting transportation to the polls, accessibility concerns, or other reasons.

Mrs. Reske took a moment to acknowledge the passing of Morgan Morgan the Site Manager of Service Older Adults (SOA) who passed away on July 15th. She was a very devoted advocate for the seniors and great person to work with she will truly be missed.

Mrs. Reske gave updates on menu changes, opening of Senior Dining Sites and Safety and Sanitation measure during the COVID-19 health crisis.

a. Menu Discussion

On March 16th we had to close all the congregate dining sites due to the outbreak of COVID 19. We had to transitioned from serving hot lunches to cold bag lunches. We started curbside carryout bag lunches at the meal sites for the seniors who were able to drive and pick up their meal. With the assistance of Able Access transportation who delivered meals to the seniors' homes who were not able to pick up a bag lunch. We will be serving cold lunches through the end of the year.

- Upcoming in September there will be salads added to the menu:
 - Caesar Salad
 - Chef's Salad
 - Taco Salad
 - Tortellini Salad

b. Opening of Senior Dining Sites Discussion

The Senior Dining Sites will remain closed until the end of 2020. We will have to get the approval from the State and Steering Committee for the opening of the senior dining sites.

c. Safety and Sanitation Measures during Meal Preparation and Service and during COVID-19 public health crisis

We are taking precaution with preparation of meals and services. The drivers are required to wear a mask before entering the facility. The caterer employees must fill out a COVID-19 questionnaire and must practice social distancing and handwashing at the dining sites.
