a. CORE Team – Repurposed the OEM Special Events team to focus on community engaged efforts. The Special Events coverage will still be provided as a mission of the CORE Team. With Fiserv Forum shut down from events, the team is assisting with COVID-19 testing and potential vaccination campaigns. Future endeavors would include community education and other initiatives focused on the community needs.
