SUBJECT: Authorization to enter into Agricultural Lease Agreements with D&S Farms in the amount of \$1,168.50 per year for 9.5 acres of land for the period effective January 1, 2021, through December 31, 2025; and Joseph Holterman in the amount of \$5,451.60 per year for 46.2 acres of land for the period effective January 1, 2021, through December 31, 2023; and Darrell Schaefer in the amount of \$3,271.60 per year for 25.2 acres of land for the period effective January 1, 2021, through December 31, 2023.
