

All of Block 260 of A.K. Mayhew's Addition; all of Blocks 10, 11 of Hopkin's Subdivision; all of Block 1 and 2 of R. Burke's Subdivision; all of Block 2 of Lynde's Subdivision of five acres; and vacated North 24th Place; and vacated alleys and streets included in the above; all located in the Northwest Quarter of the Southwest Quarter of Section 19, Town 7 North, Range 22 East, in the City of Milwaukee, Milwaukee County, Wisconsin, which is bounded and described as follows:

Commencing at the West Quarter corner of said Section 19; Thence South 01°07' 57" East along the West line of said Southwest Quarter a distance of 710.16 feet; Thence North 88°52'03" East a distance of 33.00 feet to the Northwest corner of said Block 261;

Thence South 01°07'27" East along the West line of said Block 261 a distance of 439.13 feet to the Southwest corner thereof;

Thence 83.21 feet along said curve to the right with a radius of 110.00 feet and whose chord bears North 69°25'15" West a distance of 81.24 feet to the centerline of vacated West Galena Street:

thence South 88°54'26" West along the said centerline of vacated West Galena Street a distance of 284.94 feet to the said centerline of vacated North 26th Street; Thence South 01°12'28" East along said centerline of vacated North 26th Street a distance of 469.56 feet to the POINT OF BEGINNING.
