3 Report from the Interim Executive Director, Department on Aging, requesting
4 authorization to extend existing contracts with D&S Food Services, Inc. and Aramark
5 Correctional Services, LLC for the period of January 1, 2021 through December 31, 2021
6 to provide food services for Milwaukee County’s Senior Meal Program serving eligible
7 seniors age 60 and older, by recommending adoption of the following:

9 **A RESOLUTION**

11 WHEREAS, the Interim Executive Director, Department on Aging (Aging), is
12 requesting authorization to enter into a one-year contract extension with Aramark
13 Correctional Services, LLC (Aramark), to provide food services beginning January 1,
14 2021; and

15
16 WHEREAS, the Interim Executive Director, Aging, is requesting authorization to
17 enter into a one-year contract extension with D&S Food Services, Inc. (D&S), to provide
18 food services beginning January 1, 2021; and

20 WHEREAS, Aging, in cooperation with the Procurement Division, Department of
21 Administrative Services, issued a Request for Proposals (RFP) on June 9, 2017, with a
22 submission date of July 14, 2017; and

24 WHEREAS, the RFP divided the congregate meal sites and home delivered
25 meals dispatch sites into two zones (Zone One and Zone Two), with proposers invited
26 to submit proposals for one or both zones; and

27
28 WHEREAS, after all reviews were completed and scores tallied, Aramark was
29 selected as the vendor for Zone One, and D&S was selected vendor for Zone Two; and

30
31 WHEREAS, Aramark is headquartered in Philadelphia, Pennsylvania, and has
32 partnered with Milwaukee County (the County) for almost 20 years; and

34 WHEREAS, Aramark has managed food services at and provided commissary
35 services to the House of Correction, where food for this contract will be prepared, as
36 well as the County Jail and the Behavioral Health Division; and

37
38 WHEREAS, D&S is headquartered in Menomonee Falls, Wisconsin, and
39 employs over 200 workers at that location where food for this contract will be prepared;
40 and

42 WHEREAS, D&S is a current partner of the County’s Senior Meals Program; and

44 WHEREAS, the Milwaukee County Board of Supervisors approved
45 File No. 17-596 on November 2, 2017, which authorized the Director, Aging, to enter
46 into a three-year contract with Aramark and D&S, with an option for two additional one-
47 year contract extensions; and

49 WHEREAS, Aging's current three-year contracts with Aramark and D&S began
50 on January 1, 2018, and ends on December 31, 2020; and

52 WHEREAS the total annual contract for Zone One is for an amount not-to-
53 exceed \$1,610,944, and the total annual contract for Zone Two, including labor, food,
54 and supplies, is for an amount not-to-exceed \$1,896,202; and

56 WHEREAS, the Committee on Finance, at its meeting of December 10, 2020,
57 recommended adoption of File No. 20-893 (vote 6-0); now, therefore,

59 BE IT RESOLVED, the Interim Executive Director, Department on Aging (Aging),
60 is hereby authorized to enter into a one-year contract extension with Aramark
61 Correctional Services, LLC, in an amount of \$1,610,944 for the period January 1, 2021,
62 through December 31, 2021, to provide Senior Meals Program food services; and

64 BE IT FURTHER RESOLVED, the Interim Executive Director, Aging, is hereby
65 authorized to enter into a one-year contract extension with D&S Food Services, Inc., in
66 an amount of \$1,896,202 for the period January 1, 2021, through December 31, 2021,
67 to provide Senior Meals Program food services.
