WHEREAS, per Section 56.30 of the Milwaukee County Code of General Ordinances, the Director, Department of Health and Human Services (DHHS), is requesting authorization to enter into 2021 Professional Services Contracts for the Division of Youth and Family Services (DYFS), DHHS; and

WHEREAS, the contracts reflect the procurement of the following services to support both the youth residing in the Detention Center, as well as DYFS-DHHS staff: detention physician and medical services, and detention psychiatric nursing; training and technical assistance in the development of a Residential Treatment Center; as well as medical and pharmaceutical supplies and medications; and

WHEREAS, there is no budgetary impact associated with this request, as funding for these contracts totaling \$1,066,838 is included in the 2021 Adopted Budget; and

WHEREAS, the Committee on Finance, at its meeting of December 10, 2020, recommended adoption of File No. 20-859 (vote 6-0); now, therefore,

BE IT RESOLVED, the Director, Department of Health and Human Services, or her designee, is hereby authorized to enter into Professional Services Contracts in the amount of \$1,066,838 with the following organizations, for the period beginning January 1, 2021, through December 31, 2021, in the amounts and terms enumerated as follows:
