21 22 23 24	WHEREAS, an evaluation panel concluded that the firm of Baker Tilly US, LLP (Baker Tilly), had the highest score among the five firms submitting proposals; and
25 26 27 28	WHEREAS, the Baker Tilly proposal includes an aggregate not-to-exceed fee quote of \$2,270,391, to perform annual County-wide audit services involving the years 2020-2025; and
29 30 31	WHEREAS, Baker Tilly Virchow Krause, LLP, committed to 34 percent participation (at the subcontracting level), by a TBE firm as part of the contract; and
32 33 34	WHEREAS, the Committee on Finance, at its meeting of December 10, 2020, recommended adoption of File No. 20-883 (vote 6-0); now, therefore,
35 36 37 38 39	BE IT RESOLVED, the Milwaukee County (the County) Board of Supervisors hereby authorizes and directs the Director of Audits, Audit Services Division, Office of the Comptroller, to execute an agreement with Baker Tilly US, LLP (Baker Tilly), for annual County-wide audit services, covering the five-year period 2020 – 2024, with the option to renew for an additional one-year at the County's discretion; and
40 41 42 43	BE IT FURTHER RESOLVED, that the fee to be charged in 2021, the first year of the five-year contract, will involve County-wide audit services covering the year ending December 31, 2020; and
44 45 46	BE IT FURTHER RESOLVED, that the 2021 fee shall not exceed \$350,475, and shall be paid from appropriations in the 2021 Adopted Budget; and
