- A. The Office of the Comptroller is requesting approval of the attached initial authorizing resolution of a not-to-exceed amount of \$86,280,000. The resolution also authorizes the reimbursement of expenses related to projects that occurs prior to the issuance of the bonds/notes.
- B. The estimated debt service costs for the not-to-exceed amount of \$86,280,000 of Corporate Purpose Bonds/Notes is \$117,100,000, including \$30,820,000 in interest.
- C. The bonds and notes issued in 2021 will not impact the 2021 operating expenses. It is anticipated that the first principal and interest payments will occur in 2022. The estimated debt service expenses for 2022 from the bonds and notes issued in 2021 is approximately \$8,000,000.
- D. The total estimated debt service associated with the total not-to-exceed amount of \$86,280,000 is based on five individual debt schedules. The combined schedule includes a 15-year financing schedule of approximately \$37,910,000 for general projects, a 10-year financing schedule of \$20,185,000 for bus replacements/Bus Rapid Transit, a 15-year financing schedule of \$14,935,000 for the Forensic Science Center project, a 4-year financing schedule of \$8,605,000 for fleet equipment replacements and a 5-year taxable note financing schedule of \$4,645,000 to finance potential private activity projects. A more refined estimate will be provided when the Parameters Resolutions are submitted to the Finance Committee for approval.

The not-to-exceed debt service schedules also include costs of issuance. The estimated cost of issuance reflects the 2 percent maximum allowable amount. A 5.0 percent coupon is assumed for each of the bonds/notes. The actual interest rates will be based on market rates on the day of the sale and premiums that may be received.
